DISCLAIMER

Francesca & Co. Travel is not responsible for acts or omissions of the Suppliers or their failure to provide services.

Francesca & Co. Travel assumes no responsibility for and shall not be liable for any refund, personal injury, property damage, or other loss, accident, delay, inconvenience, or irregularity which may be caused by: (1) any defaults, wrongful or negligent acts, or omissions of the Suppliers; (2) any defect in or failure of any vehicle, craft, equipment, or instrumentality owned, operated, or otherwise used or provided by the Suppliers; (3) any wrongful or negligent acts or omissions on the part of any other party not under Francesca & Co. Travel’s control; and (4) any Supplier price drop after your travel arrangements have been confirmed, paid in full, or ticketed

You hereby consent to any such price increases and authorize your credit or debit card to be used for them.

Travel** and its agents, employees, officers, directors, associates, affiliated companies, and subcontractors **HARMLESS** against any and all liability, actions, causes of action, debts, suits, claims, and demands of any and every kind and nature whatsoever which you now have or which may hereafter arise out of or in connection with your trip. **THE TERMS OF THIS AGREEMENT**
